And the dive into these Part 32 issues is just the beginning – later that afternoon, the Accounting group will roll up their sleeves with Mitchell McCoy, Curtis Blakely & Company for some freshening of "Time Code Reporting — Foundations of Accounting" and finish off the day with a segment on "NECA & USAC Audits – Oh My!" Sometimes it really is just more than we think we can take isn't it?

After an evening of enjoying Arlington, we will return Friday morning for breakfast and our closing General Sessions. Starting off our general sessions will be *Todd McElmurry*, *Curtis Blakely & Company* with a return performance of "*Excel & More — Tips and Tricks that really work!*" (and this time they really will work!) Presenting with Todd will be *Michael O'Neill*, *Eastex Telephone Cooperative*, *Inc.* Continuing in the technology arena we will then move to a *Technology Show — Gadgets and Gizmos You and Your Customers Just Have to Have*" presented by *Tim Owens*, *Cronin*.

Before we adjourn, Weldon will give us a more in depth legislative update, touch on current regulatory issues and give a State of the Association overview.
