The 2017 Legislative Day in Austin will be a joint TSTCI/TTA event scheduled for Tuesday, February 21, 2017, at the Sheraton Austin at the Capitol. Another tradition that we will continue, is the drawing for the \$1,000 scholarship designations by those legislators that attend our reception.
